VAT

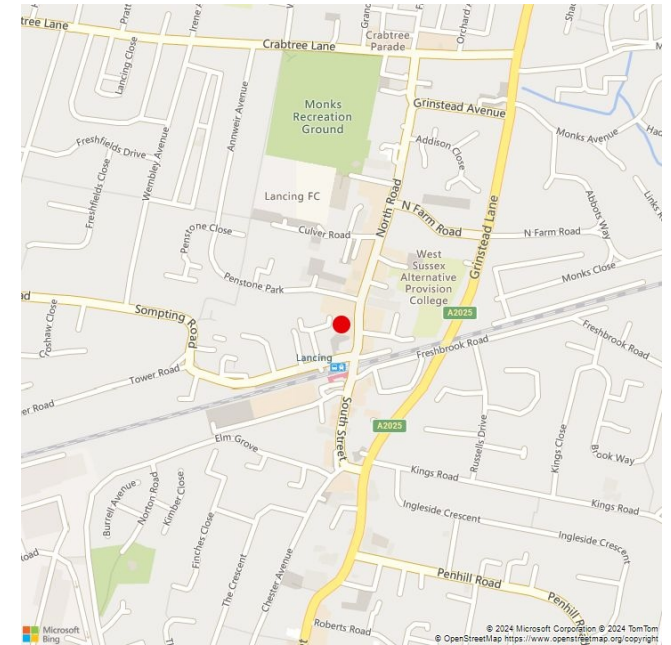
